


Symantec CloudSOC Gateway certificate change

On Dec 12, 2019 the certificate authority (CA) certificate used for Symantec CloudSOC Gateway will expire. Due to the expiration of the certificate in December, we are aiming to change our CA certificate on November 7th, 2019. The certificate contains the same security properties as before and will be required for encrypted traffic interception by "gw.elastica.net" and "mgw.elastica.net".


